



## CREATE YOUR LASTING LEGACY AT THE BEAUTY OF SIGHT

### GIFT IN YOUR WILL OR LIVING TRUST

Planning for the future and creating a legacy are the most effective ways to make a lasting impact. A gift through your estate, in your will or living trust, known as a **bequest**, guarantees that your legacy endures.

**In a simple single sentence**, *(possible hyper link from and to Planned gift intention form and bequest language)* you can confirm your commitment to support the life-changing work of the Beauty of Sight. Your legacy gift can be a **specific dollar amount, percentage of your estate, securities, real estate or other property or the remainder of your estate after all other provisions are satisfied (residuary bequest)**.

The following sample wording can be included in your Last Will and Testament or Trust to ensure your legacy to the Beauty of Sight Foundation. Your gift will advance its mission and thereby improve the lives of all we serve today and for generations to come. You may wish to consult with your attorney for more extensive language to be tailored to your needs. Thank you.

### SAMPLE BEQUEST LANGUAGE FOR THE BEAUTY OF SIGHT FOUNDATION

#### Unrestricted:

"I give to the Beauty of Sight Foundation, a Florida corporation in Miami, Florida, the sum of \$ \_\_\_\_\_ or \_\_\_\_\_ percentage of my estate or \_\_\_\_\_ a description of securities, real estate, or other property to be used by the Beauty of Sight for its unrestricted purposes."

#### To designate to a particular purpose:

"I give to the Beauty of Sight Foundation, a Florida corporation in Miami, Florida, the sum of \$ \_\_\_\_\_ or \_\_\_\_\_ percentage of my estate or \_\_\_\_\_ a description of securities, real estate or other property to be used by the Beauty of Sight to support \_\_\_\_\_ (choose capital, research or endowment)."

#### The Beauty of Sight Residuary Bequest:

"I give to the Beauty of Sight Foundation, a Florida corporation, Miami, Florida, all or \_\_\_\_\_ percentage or of the rest, residue, and remainder of my estate, both real and personal, to be used by the Beauty of Sight to support in ongoing efforts."

#### Add to your designated bequest intention:

"If it is ever impossible, impracticable, or inadvisable to use the gift in the manner set forth above, then my gift shall be used in an alternative manner that honors as closely as practical my original intentions as specified above."
